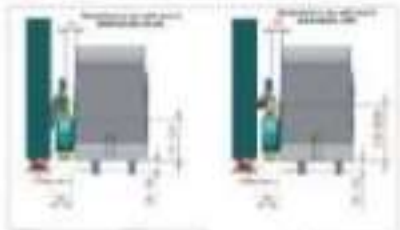
**1. Ergonomics**
